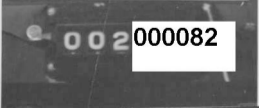



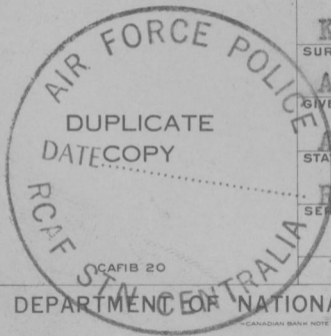

Dear Corporal Kalichuk:

By proclamation of the Governor in Council, Part II of the Public Service Superannuation Act became effective on 1 January 1955. With the coming into force of the new part of the Act, the Supplementary Death Benefit Plan which includes members of the Regular Forces became effective on 1 January 1955.

All members of the Regular Forces are participants in the Supplementary Death Benefit Plan from 1 January 1955, or from the date of becoming a member of the Regular Forces, whichever is the later, except those who were members of the Regular Forces on 1 July 1954 and elected on or before 1 November 1954 not to participate in the Plan.

As your retirement from the RCAF (Regular) is not effective until ~~23 January 1955~~, you will be covered by the Plan until the last day of the month in which your retirement becomes effective or until ~~31 January 1955~~. In accordance with the provisions of the Plan you will be required to contribute at the rate of \$1.20 per month from 1 January 1955 to ~~31 January 1955~~. This contribution will be recovered as a deduction from your pay account in the normal manner.

Subject to the terms and conditions of the Plan, a member of the Regular Forces may, at the time of his release or transfer to the Reserves, elect to continue to be a participant. Attached as Appendix "B" is an information circular stating the qualifications required to become an elective contributor and the action required to continue as a participant after release. The annual contribution rates payable per \$1,000.00 dollar basic benefit are shown in Appendix "A" to this letter.

It is requested that page 3 of Appendix "B" be completed by you and returned to this Headquarters as soon as possible. An addressed envelope is enclosed for this purpose.

If you desire to elect to continue as a participant you must follow the procedure given in page 3 of the information circular and ensure that the election form Appendix "C", properly completed, is despatched by you not more than 30 days after the last day of the month in which your release is effective.
