- The attached CFDENC Card is returned to your Headquarters annotated that the 1st Clasp to the Canadian Forces Decoration is not recommended for the subject SGT and that it be reconsidered in one year's time in Sep 69.
- The decision to not recommend the award is based on a perusal of SGT Kalichuk's confidential file which indicates that he was placed on Acknowledgement of Counselling at CFB Centralia for a period of three months on 17 Jan 63 to 17 Apr 63. He was again placed on verbal counselling at CFB Clinton from 7 Sep 66 to 6 Jan 67 due to a Military Police memorandum from CFB Centralia 30 Jul 66. In both cases, excessive use of alcohol was the cause for being placed on counselling.
- It would seem that the requirement to be placed on counselling twice in a period of five years does not constitute the type of conduct which would warrant the award of the Clasp at first eligibility. Therefore, the award of the 1st Clasp is not recommended at this time, but it is recommended that reconsideration for the award be made in one year's time.







# DISQUALIFICATION NOTES (Extracts from AFAO 18.00/06)

- para (10) App. "A", para (5) requires that all officers and men of the Canadian Forces shall be certified by the responsible service authorities as efficient and in every way deserving of the award. The certification shall not be signed unless the officer or airman has Very Good Conduct.
- para (11) For the award of this decoration no officer or airman shall be considered to have Very Good Conduct if he has been found guilty of an offence by a service tribunal during the last eight years of service claimed for the award and received any of the punishments, with the exception of fines and minor punishments, listed in QR(Air), art 104.02.
- para (12) In addition, an officer or airman shall forfeit for the purpose of the award of the Canadian Forces' Decoration, a complete year's service for each year in which any punishment, other than a fine or minor punishment, is received.
- para (13) The conduct requirement for the award of a clasp to the Canadian Forces' Decoration shall be the same as for the decoration itself.
- para (20) An officer or airman who is on probation because of inefficiency shall not be recommended for the award of the Canadian Forces' Decoration until his probationary period has been served and he has been satisfactorily reported upon.
- para (21) When a CO has or is about to report adversely upon an officer or airman he shall not be recommended for the award of the Canadian Forces' Decoration until the cause for the adverse report has been remedied and the officer or airman is again the subject of a satisfactory report.
- para (22) If, during the period between the date of a recommendation for the Canadian Forces' Decoration and the date of the award is promulgated, anything occurs which indicates that the applicant is not in every way deserving of the award, full particulars shall be forwarded to AFHQ by message.
- para (23) In exceptional circumstances the requirements of para (11) and (12) may be waived on the authority of the CAS.

- After Sgt Kalichuk's trial at St Thomas when he was at Aylmer there was a proposal to transfer him to Clinton. The CO at Clinton was rather unhappy about this at the time because of stories which had got around about Sgt Kalichuk's aberrations when he had been at Clinton once previously. I visited the OFP police detachment at Seaforth and unfortunately their records were not complete but the incidents were remembered.
- Finally, of course, when Aylmer was closed he was transferred to Centralia. While he was at Centralia in the year 63-64 an OFP Constable Mitchell from the Exeter Detachment spoke to me on a couple of occasions. A similar pattern to that known to have been followed by Sgt Kalichuk in the past had come to light and in fact the number of reported incidents were frequent enough that the local papers were reporting them. The description of the car and man involved fitted Sgt Kalichuk but they had not got a licence number and as well as that the evidence of children must be corroborated. At that time I let the then CO and Adjt at Centralia know of the suspicion of the police.



The ASWelO's report of 15 Jun has just recently been made available and as will be noted, was forwarded direct to SMO Station Aylmer and W/C Beach at Station Centralia, and was not available to administrative staff at the time recommendation for transfer was submitted by this unit 18 Sep 59. The allegation as reported by the Probation Officer in St.Thomas that "a similar incident of exposure at Seaforth did occur" has been thoroughly investigated by AFP at this unit with civil police authorities at Seaforth, Goderich and at Court House in County of Huron, without any foundation whatsoever that an offence did actually occur. This portion of evidence is therefore incorrect.
- 2 Psychiatric reports relating to Sgt Kalichuk, although revealing an emotionally disturbed state, do not give immediate cause for alarm or anxiety.
- This further evidence as presented therefore does not justify recommendation for release from the service at this particular time.

A number of problems were noted but it was not believed that at that point they would justify a transfer to Clinton or Centralia. Recently Sgt Kalichuk was charged with an offence relating to a juvenile but he was not convicted. However, the Probation Officer revealed to the writer a number of reports which are on file concerning Sgt Kalichuk. These were discussed with the SMO, F/L Canton, W/C Beech, RCAF Psychiatrist, and later with clinical staff at Westminster Hospital, London to which the NCO was admitted for assessment. Sgt Kalichuk has been further interviewed in this connection.

Recommendation: In order that the RCAF psychiatrist and social worker at Centralia are most available for counselling and in order that Sgt Kalichuk may make a final attempt to resolve his personal and emotional problems, it is recommended that he be transferred to Centralia or Clinton.

As discussed 11 Dec with S/L Flewelling, F/L Lipkin and Sgt Kalichuk the writer visited Mrs. Kalichuk at RR4 Walton on 10 Dec. He has also contacted Dr. Foogood, London and the family laywer Mr. McConnell, Seaforth.

The writer was very sympothetic to Mrs. Kalichuk because of her past experiences in concentrarion camps and soon efter her arrival in Canada. However, the present lagal problem is expected to be settled within the next few months and Aylmer cannot be considered too far from Goderich for Sgt Kalichuk'S attendance in court. So far as the child is concerned he is only 32 and it will not be possible to retain Sgt Kalichuk in the immediate area for the rest of his career. The precautions taken in the house ere such as could be set up in any house provided that a five or six room house is obtained. It is noted that Mrs. Kalichuk's eldest daughter is not living at home but is attending a boarding school and plans to marry an airman after graduation. Recommendation that compassionate transfer cannot be recommended at this time but that Training Command should be asked to annotate Sgt Kalichuk's file to the effect that future transfers should be to areas where special medical attention is immediately available and where PMQ's are available if possible. It is further recommended that Training Command be asked to send Sgt Kalichuk on any postings "in the narrow sense" to Centralia or Clinton that might come up in the next few months.


