

Dear Mrs. Kalichuk:

The purpose of this letter is to inform you of the various entitlements that may accrue to you as a result of your husband's service in the Regular Force.

As your husband was a participant in the Supplementary Death Benefits Plan, under Part II of the Canadian Forces Superannuation Act (CFSA), you are entitled to a benefit of \$8,250.00 and arrangements have been made to send you a cheque in this amount. This payment is not subject to income tax and should not be included in any income tax return you may be required to file.

Under the Canadian Forces Superannuation Act you will be entitled to a gross annual allowance (less any applicable income tax deductions) in the amount of approximately \$2,050.00 which will be payable for life, subject to suspension in the event of remarriage. The Act provides however, that the allowance would be resumed in the event of the dissolution or annulment of that marriage or the death of the husband by that marriage. This annual allowance is paid in monthly instalments.

The following certificates which you forwarded recently have been duplicated and the originals are returned herewith for your further use:

- a. Death Certificate of your late husband;
- b. Your Certificate of Canadian Citizenship.

It is expected that payment of the above allowance will be made in approximately three weeks.

Provision is made for an increase in annual allowances where there has been an increase in the Consumer Price Index. When authorized, the increase is calculated effective at the beginning of the year concerned and the adjustment is payable automatically without the need for any action or application by you.

Because this allowance may be subject to income tax deductions, would you please complete the enclosed Tax Deduction Declaration Form so that we will be able to make the correct recovery.

You are probably aware that your husband subscribed to the Group Surgical-Medical Insurance Plan (GSMIP) which provided, within certain limits, for the payment of your medical expenses. Should you desire to continue this insurance coverage, please complete and return the attached application form which has been marked in the spaces to be completed by you. This application should be submitted as soon as possible, otherwise you and any eligible dependants you wish to insure will be subject to a full three month waiting period before coverage commences. This waiting period will commence on the first of the month following the month in which your application is received at this Headquarters with premium payments commencing one month prior to the month in which your coverage commences.

Since you are a resident of a province in which a provincial medical care plan is in effect, full GSMIP coverage is not available to you or your dependants, but the GSMIP makes available a Supplementary Plan to pensioners and dependants. This Supplementary Plan includes those benefits of GSMIP which are not payable as benefits under the provincial medical care plan. The present GSMIP benefits for prescribed drugs, etc., as outlined in the enclosed insert, are included in the Supplementary Plan.

You will notice that the premium of \$0.73 a month does not include optional hospital benefits. Your decision to elect optional hospital benefits will depend on what coverage you may have in this regard under a commercial insurance scheme. If you are eligible for insurance under a provincial hospital insurance plan, the maximum optional hospital benefit you may elect under the GSMIP is \$5.50 a day. Under this election, the total premium would be \$1.04 a month. The premium payment you choose will be deducted from your monthly cheque.

Payment of provincial Medical and Hospital Insurance premiums may be deducted from your monthly cheque as you reside in a province where such premiums are payable. The enclosed insert outlines in detail those provinces where such premiums are payable together with the applicable rates and provides an application form which may be completed if it is intended that these premiums be deducted.

The Canada Pension Plan provides for the payment of the following benefits to survivors of a person who served in the Regular Force and has been in civilian employment since 1 January 1966 and who made contributions to the Plan for the required minimum period:

- a. A Death Benefit (lump sum);
- b. A Widow's Pension;
- c. An Orphan's Benefit.

The writer was first referred to Sgt Kalichuk's case Dec 58 because of a possible need to transfer airman closer to Seaforth where his wife presently lives. A number of problems were noted but it was not believed that at that point they would justify a transfer to Clinton or Centralia. Recently Sgt Kalichuk was charged with an offence relating to a juvenile but he was not convicted. However, the Probation Officer revealed to the writer a number of reports which are on file concerning Sgt Kalichuk. These were discussed with the SMO, F/L Cantan, W/C Beech, RCAF Psychiatrist, and later with clinical staff at Westminster Hospital, London to which the NCO was admitted for assessment. Sgt Kalichuk has been further interviewed in this connection.

Recommendation: In order that the RCAF psychiatrist and social worker at Centralia are most available for counselling and in order that Sgt Kalichuk may make a final attempt to resolve his personal and emotional problems, it is recommended that he be transferred to Centralia or Clinton.

Receipt is acknowledged of your letter dated 1 May, 1975, on behalf of the above-named ex-member of the Forces concerning his benefit under the Canadian Forces Superannuation Act (CFSA).

A review of ex-Sergeant Kalichuk's file reveals that he was released from the Forces on 28 November, 1969, under Queen's Regulations and Orders 15.01 item 4(A) "On request". As a result of his release he was awarded an annuity under the CFSA with effect from 29 November, 1969.

In view of the conditions of his release and considering his pensionable service of 24 years 190 days, he would normally become eligible for an increase to his annuity, as provided for under the provisions of the Supplementary Retirement Benefits Act (SRBA) in November, 1983, upon attaining age sixty.

As you state in your letter dated 1 May, 1975, that ex-Sergeant Kalichuk is now incapable of pursuing regularly any substantially gainful occupation and may now qualify for the increase to his CFSA annuity as provided for under the provisions of the SRBA. Attached, as requested, is the Medical Examination Form and Physician's Certificate to be completed by his doctor at his expense and returned to this Headquarters.






